## RE: PUBLIC HEARING – WWTP SEWER PLANT PROJECT

Mayor Estok opened the Public Hearing on the Waste Water Treatment Plant Sewer Project. Emily Gross Albaugh, Community Development Planner for Kankakee Iroquois Regional Planning Commission spoke first about the project. She outlined the project as applying to the Office of Community and Rural Affairs for a grant in the Water and Wastewater Program. The City is applying for a \$600,000.00 grant with a match of \$1,372,000.00 in bonds and cash on hand. The application is due July 20<sup>th</sup>.

Josh Weaver of J.P.R. Engineering explained the scope of the project which concentrates on upgrading or replacing most of the head works at the plant. The pre-treatment system needs more of the small solids and grit removed. Failure to take these particulates out of the system creates more wear on the clarifiers, pumps and screens. A general discussion took place about goals and priorities of the project. Emily noted that the award date has been moved from August 16<sup>th</sup> to August 23<sup>rd</sup>.

The Mayor closed the public hearing.

WHEREAS, the City Council of Knox, Indiana recognizes the need to stimulate growth and to maintain a sound economy within its corporate limits; and

WHEREAS, the Housing and Community Development Act of 1974, as amended, authorizes the Indiana Office of Community and Rural Affairs to provide grants to local units of government to meet the housing and community development needs of low and moderate income persons; and

WHEREAS, the City Council of Knox, Indiana has conducted or will conduct public hearings prior to the submission of an application to the Indiana Office of Community and Rural Affairs, said public hearings to assess the housing, public facilities and economic needs of its low- and moderate-income residents;

NOW, THEREFORE, BE IT RESOLVED by the City Council of Knox, Indiana that:

1. The Mayor is authorized to prepare and submit an application for grant funding to address improvements to the existing wastewater treatment plant, and to execute and administer a resultant grant including requisite general administration and project management, contracts and agreements pursuant to regulations of the Indiana Office of Community and Rural Affairs and the United States Department of Housing and Urban Development.

2. The City Council of Knox, Indiana hereby commits the requisite local funds in the amount of one million three hundred seventy-two thousand seven hundred-seventy dollars (\$1,372,770), in the form of Cum. Sewer Treatment \$120,000, Sewer Improvement \$349,253, CCD SO Equipment Repair \$10,000, CCD SO System Repair \$10,000, Sewer Operating \$123,517; BOND \$760,000, such commitments to be contingent upon receipt of WDW funding from the Indiana Office of Community and Rural Affairs.

The Mayor and any officer of the City be, and hereby is, authorized, empowered and directed, on behalf of the City to take all actions as the Mayor or such officer deems necessary or desirable to effectuate the foregoing resolutions, and any such actions heretofore made or taken be, and hereby are ratified and approved.
