### RE: RESOLUTION #2019-RE15 - ALLOCATION OF FUNDS FOR CONSTELLATION OF STARKE

Mayor Estok explained Resolution #2019-RE15 to the Council. He noted that if Constellation of Starke is awarded, the City would need to commit up to \$100,000.00 each year for four years. The amount should come in a little lower. The money will probably come out of CEDIT. He passed out a project list:

## RESOLUTION #2019-RE15

# CITY OF KNOX COMMON COUNCIL ALLOCATION OF FUNDS CONTINGENT UPON THE COUNTY OF STARKE BEING SELECTED AS A STELLAR COMMUNITY

WHEREAS, THE COMMON COUNCIL OF THE CITY OF KNOX OF STARKE COUNTY, INDIANA has authorized and supported the participation of City of Knox in a regional team application seeking Stellar Community designation from the Indiana Office of Community and Rural Affairs ('OCRA"). The regional team, branded as the Constellation of Starke ("COS") includes the four municipalities covering the County of Starke, Indiana: (1) the City of Knox, the towns of (2) North Judson and (3) Hamlet, and (4) Starke County, participating behalf of all unincorporated areas of Starke County.

On the basis of its Letter of Intent ("LOI") COS Stellar bid has heretofore been selected by OCRA as one of four finalists for the 2019 Stellar Community designation. Final preparation of the COS Stellar Community Regional Development Plan is now underway.

The COS Stellar Community Development plan has been developed with substantial public consultation and input through meetings and surveys, active participation of community leaders, and consultation with experts, officials and academics throughout the State of Indiana. This process produced a consensus for a shared vision of the future of the COS region centered on an aggressive program of investments in community improvements to leverage the COS region's outstanding natural resources, including lakes and rivers, to improve and modernize housing for all income levels, to improve social cohesion through flexible modern community facilities, healthful outdoor activities, and a network of trails, revitalize downtown districts, to address the needs of families and to combat the scourge of substance abuse and help heal the many families who have been affected by it.

The Common Council of the City of Knox, being duly advised, strongly supports the goals and plan of action set forth in the COS Stellar Community Regional Development Plan, and supports the commitment of resources necessary to implementing the plan to rapidly and dramatically transform and improve the quality of life and attractiveness of the City of Knox and Starke County for residents, property owners and visitors alike.

WHEREAS the COS Stellar Community Regional Development Plan envisions substantial investments in the community, primarily from federal funds, but also requires the allocation of local resources, including local matching funds in the amount of approximately 20%.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Knox that: The Common Council of the City of Knox hereby supports and directs that the COS Stellar Community Regional Development Plan be submitted to OCRA before the September deadline;

AND, FURTHER RESOLVED the Common Council authorizes the COS Executive Committee to apply for the Stellar Community Designation and receive funding and/or tax credits or incentives, subsequent to this designation from the Indiana Department of Transportation ("INDOT"), the Indiana Housing and Community Development Authority, the Indiana Office of Community and Rural Affairs ("OCRA"), and the Indiana State Department of Health ("ISDH"), and,

IT IS FURTHER RESOLVED, that the Mayor of the City of Knox, or his designee, is hereby, authorized, empowered and directed to execute, acknowledge, and deliver in the City's name and on its behalf, all applications, award agreements, documents, instruments, or writings, as are necessary and/or appropriate to consummate the COS Stellar Community application and receipt of any subsequent funding or commitments; and,

IT IS FURTHER RESOLVED, that contingent upon the COS being designated as the Stellar Community Designee during or about December 2019, the Knox Common Council hereby commits and allocates local match funds in the maximum amount of \$400,000.00, and not to exceed 20% of total expenditures on Stellar Community projects actually funded and built. This allocation shall be divided into four equal annual installments of a maximum of \$100,000 per year for each of the following years: 2020, 2021, 2022 and 2023. Nothing herein shall preclude the City from entering into cooperative intergovernmental agreements with other members of or contributors to the

COS regional team, but any such agreement shall be in writing and approved by the executive body of each municipality that will participate in the agreement.

THE KNOX COMMON COUNCIL HEREBY REQUESTS AND RECOMMENDS that the City of Knox consider and after due deliberation approve and join in the contingent commitments set forth herein.

Local contractors are welcome to bid on such jobs as roofs, electrical and plumbing, however there is a 30 to 90 day wait for payment. Five more homes are about ready to be approved also.

American Graffiti Night is Saturday night at the Park with a cruise in and the Academy Award winning movie. Quentin Flagg will perform at 5:30 PM, Movie at 8:00 PM.

The recent visit by the Neuter Scooter was a big success with about 180 cats done.
