She was billed for 30,000 gallons of water on her January 1 bill which was around \$366.00. She requested a check for leaks. It was discovered that the meter was leaking, which was repaired by the water department. The water department was not able to repair it until the following day because they were repairing a water main break. By the time Amie's leak was repaired another 67,000 gallons of water had gone through her meter to be reflected on her February 1 bill. A special meeting will be set between Mrs. Valledares' attorney and the City Attorney.

### RE: SUPERINTENDENTS' REPORTS

STREET: Street Superintendent Jeff Borg reported to the Board that 125 loads of leaves have been picked up. The new tractor is operating good. All other equipment is in good working order.

WWTP: Superintendent Kelly Clemons presented the Wastewater Treatment Plant Annual Report for 2019. The Miffle furnace was repaired by McGrath. Parts and labor totaled to \$273.50.

Pump #1 tripped out on January 2. Pulled the pump out and found it was full of wipes.

Low level alarm caused by accumulated grease in the wet well on January 18.

Digester #1 - T-valve will need to be replaced. She is waiting on quotes. Seal has failed and mounting flange has deteriorated.

Scada computer was upgraded from Windows 7 to Windows 10.

November and December 2019 reports.

Getting quote for UV bulbs and accessories.

POLICE DEPT: Chief Harold Smith reported to the Board that there was ticking and tapping in 2014 Dodge Charger squad car. They took it to Town & Country in Plymouth. It needed various engine repairs amounting to \$2,300.00.

He is ordering equipment for the new Tahoe.

Chris Kisela turned in his resignation on January 2. He is taking remaining vacation days taking him to January 24 as his last day paid. He has been hired as a resource officer in North Judson.

Building and Code Compliance Director Kenny Pfost: He has sent out rental registrations and contract registrations and renewals.

WATER DEPT: Water Superintendent Tim Lindewald reported to the Board that well #2 is back in service. They are waiting on second sample.

He asked for approval from the Board to get bids only on tuckpoint, insulation and siding for the water plant. He stated that the work they have done inside the plant has already made a big difference on the heating bill the last couple of months. Mayor Estok made a motion for the approval of Superintendent Lindewald getting quotes on tuckpoint, insulation and siding for the water plant. Motion was seconded by Board Member Dodge and was passed by a vote of Two (2) Ayes and No (0) Nays.

They fixed a water leak at 420 Star Court.

At 424 Cannon Drive they put in pit, pulled old curb stop and shut off at corp so there is no water under the driveway.

They changed 13 meters.

They put in curb a stop at the pit at 1009 Short Drive.

Scot Dunlap from Neptune informed the Board that by the end of 2020 we will be required to switch all utility customers to a cloud based software. He presented a quote of \$10,500.00. This amount includes the annual maintenance fee. Mr. Dunlap also discussed other options the City may want to look at in the future. A visual presentation was shown after the meeting was adjourned for those interested.
