Tim Howard property owner requested a variance that would allow the lot commonly known as 1149 South Roosevelt Road, Knox, Indiana to have a less than required side yard setback on the property that is currently zoned as R-1 Residential. The requirement is 80ft the lot would be 75.2ft. The property owner at 1101 Roosevelt was present and expressed concerns. President Skinner closed the hearing at 6:33. Vice President Jenkins made motion to approve the variance, Secretary Hoekman seconded the motion. Carried 3-0

Public Hearing: Aaron Anderson, Variance Request – President Skinner opened the public hearing at 6:41pm, and read the Legal Notice. Aaron Anderson property owner requested a variance that would allow a steel shipping container to be used as an accessory building on the property currently zoned A - Agriculture. Property commonly known as 1595 North 600 East Knox, Indiana. Mr. Anderson stated the container will be placed far from other properties and would be painted to match other structures on his property. None opposed.
